The community is served by the Trails at Crowfoot Metropolitan District Nos. 1-3 (collectively the "Districts"). The Districts were formed to support the development and maintenance of vital infrastructure and amenities for the community. District No. 3 is responsible for the operations and maintenance of the smaller community parks, open space areas and trails, certain common area landscaping and snow removal, detention ponds, fencing adjacent to common areas, and the community pool.

Please have your receptacles placed curb-side by 7:00 A.M. the day of pick-up to ensure that services are not missed.

Please note that delivery of new trash and recycling receptacles will take approximately 7 days to arrive. Trash and recycling services are paid for by District No. 3 through a funding arrangement with the Master Owners Association.
